The Managing Director is the Chief Executive Officer of the Company and responsible to the Board of Directors as per the provisions of the Articles of Association of the Company. The position shall be responsible for overall administration, finance, technical matters, corporate planning and business development of the Company. Other important tasks are to coordinate activities regarding operational and functional systems of the organization, liaise with national and international financial institutions/entities & development partners for sourcing, sanctioning and mobilization of fund for power plant /development projects and negotiate with stakeholders etc.
